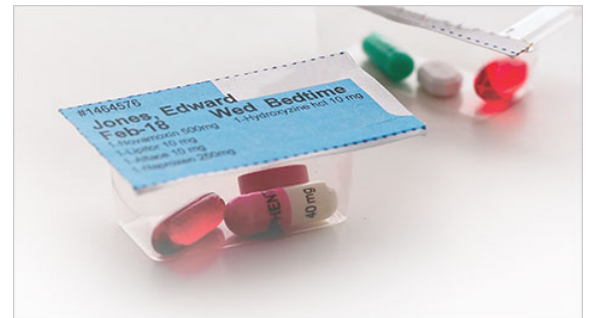

# NEW SHINGLES VACCINE AVAILABLE

## Shingrix (herpes zoster vaccine recombinant, adjuvanted) Overview

The CDC's Advisory Committee on Immunization Practice voted to recommend Shingrix (RZV) as the preferred vaccine for immunocompetent adults age 50 years and older to prevent shingles and related complications. They also voted to recommend Shingrix (RZV) for immunocompetent adults previously vaccinated with Zostavax (ZVL).

Shingrix is NOT a live attenuated virus vaccine; however, since the efficacy studies were performed in healthy adults, the ACIP voted to recommend for immunocompetent adults until more testing/data is collected.

### Efficacy Estimates for Shingrix and Zostavax

	Ages 60 to 69 Years	Ages 70 to 79 Years	Older Than 80 Years
Shingrix	97%	91%	91%
Zostavax	64%	41%	18%

Shingrix is a series of 2 doses with the 2nd dose being given 2-6 months after the 1st dose. ACIP expert opinion recommended waiting that Shingrix should not be given < 2 months after receipt of Zostavax.

### Who Should Get Shingrix?

The CDC recommends the vaccine for healthy adults 50 and older. Including those who:

- Have had shingles
- Received Zostavax (unless Zostavax was given <2 months ago)
- Are not sure if they had chickenpox
